## Founders Day celebration is planned for June 11

**T**he physician was exhausted. He had spent the entire day traipsing across town visiting with old colleagues, friends, patients and other acquaintances. It was a task he had put off far too long and he knew it could wait no longer, for his very life might be on the line.

The physician was Dr. Bob, the date was June 10, 1935, and his task was to complete the 9<sup>th</sup> step: Made direct amends to such people wherever possible, except when to do so would injure them or others.

For Dr. Bob, the result of his action was his first day of permanent sobriety; for us it was the founding of Alcoholics Anonymous, which counts its existence from that day.

This year, the Bladen, Cumberland, Robeson Central Office is hosting a celebration of A.A.'s 76<sup>th</sup> anniversary on Saturday, June 11 at Myrover-Reese Halfway House on Wilkes Road.

The celebration, which will run from 9 a.m. to 6 p.m., will feature food, activities, a raffle and a speaker.

It will also feature something new this year: shade. Al S., chairman of the Founders Day committee, has arranged for two 20-foot-by-20-foot canopies. At past events, the inability of people to get out of the sun was a concern for many. The hope is the shade will allow people to stay longer at the event.

Food will be served and will feature barbecue and fried chicken. Participants are encouraged to bring a dessert to share.

Picnic-type activities are in the planning stages, but the list is incomplete at this printing.

The traditional Founders Day raffle will also be held and the BCR-CO is accepting donated items for it.

Jackie M. of the Central Group said she is seeking prizes for both adults and children. Prizes in the past have included things from A.A. literature and tapes to electronics.

Items may be dropped off at the Alco Club on German Street. Jackie said to put her name on anything left at the club for the raffle. She said she usually is

at the club after 4 p.m. Prizes can also be donated at the Central Office on Green Street. The office is open Tuesdays and Thursdays from 10 a.m. to 2 p.m.

An A.A. speaker has not yet been announced. The time of the address is tentatively set for 3:30 p.m.

Everyone is welcome to attend the celebration and members are encouraged to bring their friends and families, including children.

Al S., said that while the Central Office plans the event and makes sure "it comes off without a hitch," it is still dependent on its members for financial support.

He said that A.A. attendees will be asked to make a donation to help pay the picnic's costs.

Suggested donations range from \$1 per year of sobriety, to the cost of a drink, to whatever one feels he or she can afford.

## Area 51 General Assembly

# Webs, vines and aliens

Discussions at the spring Area 51 General Assembly included a how to session on signing up for email notifications on North Carolina's A.A. website, the budget problems of the Grapevine and why an alien figure was making a guest appearance in a slideshow presentation by the Area's delegate to the national conference.

The session on the web by the subcommittee chairman noted the Area 51 website had 1,500 unique visitors, but less than 2 percent of them were accessing the members section. He said only 70 members were taking advantage of the electronic notification for documents. The Internet committee encourages GSRs and DCMs to sign up for the notification for agendas and other information to help the state organization save on mailing costs.

The report included a PowerPoint demonstration on how to sign up for email notices from the area. Each district has been assigned a password to access the members' area. There they can click on email notifications a fill out a form. After filling out the form, users will get a message saying "Success ... you have subscribed to email notification." Don't believe it, said the subcommittee chairman, Glen V. Without going into technical explanations, he said this flaw cannot be fixed, but that users should then check their email for a message from Major Domo. That email contains a link that must be clicked on to actually activate the notices. It then will say the process has been completed.

As the subcommittee chair took questions, one GSR in the audience noted he had followed the instructions along on his cell phone and had successfully registered for the program – which drew laughter and applause from the assembly.

Jennifer D., the area's delegate to the 61<sup>st</sup> General Services Conference reported on her trip to New York and conference business. To hand out to fellow delegates, she took along

magnets featuring a cartoon alien, which has become the unofficial mascot for Area 51. She said not all the delegates that she gave magnets got the connection, at first, to that other Area 51 in Nevada.

On conference business, she reported the GSO gets 43 percent of its funding from contributions and 57 percent from literature sales. Literature sales, however, are down. The switch to digital sources for literature is taking a bite out of that source of income. She said the financial information has spurred her to now give \$5 in 7<sup>th</sup> tradition contributions at all home group meeting she attends and \$2 at non home group meetings.

The highlight of the report was the condition of The Grapevine magazine. Jennifer said she is now the chair of the Grapevine committee. Her message to the assembly was simple, "If you want to save the Grapevine, if you think it is important, you need to subscribe.

The Grapevine she said continues to lose money and staff levels have been cut.

A report later in the day by the area's Grapevine coordinator, Debbie M., indicated that if an additional 4,800 subscriptions, including digital subscriptions, were sold this year, The Grapevine would be able to balance its budget. Only 48 new subscriptions would need to be sold in each area to reach that goal, and she encourage members to make that commitment.

In the only voting item on the agenda, Newton P. was elected the state's archivist.

The assembly was attended by 265 voting members, with 178 needed for a quorum.

# Are we really self supporting?

*This is the second part of a three-part series on the Seventh Tradition.*

This is about our giving. I hope I've convinced you in installment 1 of this need. How can we increase our contributions? The last installment will concern cost cutting and spending.

All of us are familiar with the basket. What goes in to our basket is completely dependent upon a few factors. They appear to me to be conscience, habit, duty, peer pressure and group need. Maybe, I've missed one or two, such as pride and selfishness. Some that you think of may be subsumed within the above. However, our contributions simply don't meet the needs. These for the most part, tend to put a lid on the amount we give. They also "set the standard" of giving within a group.

For good or for ill, one can look through the receipts of a group and, within reason, tell a lot about a group. Is it stingy? (Selfish) Is it poor? (probably not) What about spiritual gratitude? Could it be ignorance/education? The problem for the group, The BCR-CO, District 51, Area 51 and GSO is how to match giving with need. Sheesh, looks a lot like a need for a group inventory (from the heart not the head). Once we inventory we must decide upon a course of action to change the limiting factors. Do you think that the amount you pitch in has a lot to do with how recovered we are, how spiritual we are and our level of gratitude? How do you and your group check out?

How about comparing your group to other groups? A good place to do this is at our district meetings.

You may ask, "Carl, just how do we go about changing the factors

which limit giving?" My answer is simple: use the steps and traditions as a group exercise to enlist change actions – exactly what you did when you recovered. Just begin with honesty, open-mindedness and willingness, set some goals and use two way prayer to help you make a plan and implement it – as a group. We don't call it a group conscience (guided by God) for nothing.

Now about a very personnel aspect in which we should all search ourselves and our groups. How grateful are you for return of your life, happiness and current productivity, not to mention your sobriety? How much are you saving on alcohol that you no longer consume? You could also consider other costs, such as lawyers, bond, repairs to damaged property or restitution for wrecked property. How much are you returning to help God reach out to the suffering?

You know, it's curious that we all prayed the third step prayer but we apparently don't think of this in terms of ourselves financially. Perhaps this is because in spite of all our 4th step efforts we are, at least in some measure, still wantonly selfish. Are you and your group still caught in the trap of selfishness, self-centeredness? Well, we all know the quote from the top of page 62 in the Big Book. I just wonder ...

So how can we increase our giving? How about activating that 3rd step prayer and give as He di-

rects. After all, The Power Greater Than You did give you back your life – how do you think He revalued your life and the life of the group where you belong? More than a buck a meeting I'll wager. How much have you saved on a weekly basis? Ask God to show you how to increase His spiritual coffers to further the message and aid the newcomer and build up a spiritual financial account to help another alcoholic help a future member.

Another thought for us recovered members: When you were fresh and full of joy, how many meetings did you go to? Let's say six. Today how many? For me, it is usually 3. So at a dollar a meeting I'm actually contributing less in current dollars and the present value of those dollars buys about half as much (remember the stamp). So \$6 turns into \$3, and then, because of inflation, is reduced to \$1.50. This while real costs escalate.

So in today's money, considering the number of meetings I go to, I should be contributing about \$3 at each meeting – just to keep even. But remember those pesky increases in expenses I discussed with you in our first little talk? It looks like I should up it to at least \$5 per meeting today. That's just me, not you. I hope you'll be even more generous and by so doing shame others into giving more (see how the limiting factors can help you get me to do the right thing).

Use two way prayer for this and see what The One True Friend of us all tells you in your heart of hearts. Then, of course, do it!
